- Bids may be submitted via multiple methods:
 - As there are similar items Valid bids must contain the Auction Item # AND bids must increase by at least the stated minimum increments for the item.
 - The auction items will be displayed online with the opening bid amounts and bidding increments – The official "CURRENT" bid amounts for auction items will be maintained in the Parish Office (773) 767-1523.
 - In terms of identical bids being received the FIRST bid received/opened,
 etc. with all proper details will be deemed as the official CURRENT high bid.
 - o Call and bid via phone to the Parish Office (773) 767-1523.
 - o A max of three bids per phone call up until Thursday, 11/4/2021 at 6pm.
 - Stop by the parish office and complete a bid form.
 - Drop a bid form in the Parish Office mail slot by noon on Thursday, 11/4/21.
 - Mail in (6135 S. Austin Avenue, Chicago, IL 60638) bids must be received by end of day Wednesday, November 3rd.
 - o Drop off a bid form in the Saturday/Sunday Offertory.
- Bidding closes at 6:00 PM on Thursday, November 4th. Parish Office phones will continue to be answered until 6:00 pm on Thursday 11/4/21 to receive final bids only one bid per phone call on the final day of November 4th.
- Winners of all bids will be called on Monday, November 8th.
- Winners will have 7 days to pay/claim their winning auction item(s). All payments must be cash, check, or money order at this time.
- Items not claimed/paid for by 4 pm on Monday 11/15/21 will then be offered to the next highest bidder for claiming/payment.
- Please be understanding if the process is not perfect. The parish is trying something new so let's have fun and raise some funds!
